Page 86, strike line 19 and all that follows through page 87, line 2, and insert the following:

- 4 2015, if the total amount of OCS receipts in a
- 5 fiscal year derived from leases included within

- 8 graph (B), the Secretary shall share 60 percent
- 9 of the difference between such total amount and

Page 42, line 11, strike “and” and insert “or”.

Page 42, line 12, strike “and” and all that follows through “such” on line 15.

Page 178, beginning on line 16, strike “sale” and all that follows through the period on line 17 and insert “sale through a competitive sale process at fair market value.”.

Page 178, line 23, and on page 179, line 15, insert “Transfer and Conveyance of Properties in the District of Columbia,” before “Map Number” each place it appears.

Page 179, line 18, strike “(map number)” and insert “(Transfer and Conveyance of Properties in the District of Columbia, Map Number 869/80460, dated July 2005, page 22 of 28).”.

Page 179, after line 19, insert the following:

The Secretary may retain from sale proceeds and spend without further appropriation up to \$1,000,000 each year to implement land sales under this subsection, including hiring contractors and appraisers.

Page 179, line 22, insert “from funds received from the sale of land under subsection (b)(1)” immediately after “\$10,000,000”.

Page 180, line 15, insert “all right, title and interest of the United States in” after “convey”.

Page 180, line 24, and on page 181, line 16, strike “(map number)” each place it appears and insert “(Transfer and Conveyance of Properties in the District of Columbia, Map Number”.
