

**AMENDMENT IN THE NATURE OF A SUBSTITUTE  
TO H.R. 374  
OFFERED BY MR. POMBO OF CALIFORNIA**

Strike all after the enacting clause and insert the following:

1 **SECTION 1. PUYALLUP INDIAN TRIBE LAND CLAIMS SET-**  
2 **TLEMENT.**

3 (a) IN GENERAL.—The Secretary of the Interior  
4 shall—

5 (1) accept the conveyance of the parcels of land  
6 within the Puyallup Reservation described in sub-  
7 section (b); and

8 (2) hold the land in trust for the benefit of the  
9 Puyallup Indian tribe.

10 (b) LAND DESCRIPTION.—The parcels of land re-  
11 ferred to in subsection (a) are as follows:

12 (1) PARCEL A.—Lot B, boundary line adjust-  
13 ment 9508150496, as depicted on the map dated  
14 August 15, 1995, held in the records of the Pierce  
15 County Auditor, situated in the city of Fife, county  
16 of Pierce, State of Washington.

17 (2) PARCEL B.—



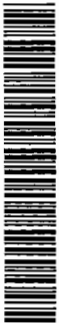
1 (A) IN GENERAL.—Parcel B shall be com-  
2 prised of land situated in the city of Fife, coun-  
3 ty of Pierce, State of Washington, more par-  
4 ticularly described as follows:

5 (i) Lots 3 and 4, Pierce County Short  
6 Plat No. 8908020412, as depicted on the  
7 map dated August 2, 1989, held in the  
8 records of the Pierce County Auditor, to-  
9 gether with portion of SR 5 abutting lot 4,  
10 conveyed by the deed recorded under Re-  
11 cording No. 9309070433, described as fol-  
12 lows:

13 (I) That portion of Government  
14 lot 1, sec. 07, T. 20 N., R. 4 E., of  
15 the Willamette Meridian, described as  
16 commencing at Highway Engineer's  
17 Station AL 26 6+38.0 P.O.T. on the  
18 AL26 line survey of SR 5, Tacoma to  
19 King County line.

20 (II) Thence S88°54'30" E., along  
21 the north line of said lot 1 a distance  
22 of 95 feet to the true point of begin-  
23 ning.

24 (III) Thence S01°05'30" W87.4'  
25 feet.



1 (IV) Thence westerly to a point  
2 opposite Highway Engineer's Station  
3 AL26 5+50.6 P.O.T. on said AL26  
4 line survey and 75 feet easterly there-  
5 from.

6 (V) Thence northwesterly to a  
7 point opposite AL26 5+80.6 on said  
8 AL26 line survey and 55 feet easterly  
9 therefrom.

10 (VI) Thence northerly parallel  
11 with said line survey to the north line  
12 of said lot 1.

13 (VII) Thence N88°54'30" E., to  
14 the true point of beginning.

15 (ii) Chicago Title Insurance Company  
16 Order No. 4293514 lot A boundary line  
17 adjustment recorded under Recording No.  
18 9508150496, as depicted on the map dated  
19 August 15, 1995, held in the records of  
20 the Pierce County Auditor.

21 (B) EXCLUSION.—Excluded from Parcel B  
22 shall be that portion of lot 4 conveyed to the  
23 State of Washington by deed recorded under re-  
24 cording number 9308100165 and more particu-  
25 larly described as follows:



1 (i) Commencing at the northeast cor-  
2 ner of said lot 4.

3 (ii) Thence  $N89^{\circ}53'30''$  W., along the  
4 north line of said lot 4 a distance of  
5 147.44 feet to the true point of beginning  
6 and a point of curvature.

7 (iii) Thence southwesterly along a  
8 curve to the left, the center of which bears  
9  $S0^{\circ}06'30''$  W., 55.00 feet distance, through  
10 a central angle of  $89^{\circ}01'00''$ , an arc dis-  
11 tance of 85.45 feet.

12 (iv) Thence  $S01^{\circ}05'30''$  W., 59.43  
13 feet.

14 (v) Thence  $N88^{\circ}54'30''$  W., 20.00 feet  
15 to a point on the westerly line of said lot  
16 4.

17 (vi) Thence  $N0^{\circ}57'10''$  E., along said  
18 westerly line 113.15 feet to the northwest  
19 corner of said lot 4.

20 (vii) Thence  $S89^{\circ}53'30''$  east along  
21 said north line, a distance of 74.34 feet to  
22 the true point of beginning.

23 (3) ADDITIONAL LOTS.—Any lots acquired by  
24 the Puyallup Indian tribe located in block 7846,  
25 7850, 7945, 7946, 7949, 7950, 8045, or 8049 in the
