“On May 15, 2011, ASRC, along with eleven other co-plaintiffs, filed a lawsuit in *ASRC, et al. v. Salazar et al.*, case no. 3:11-cv-00106-RRB (now consolidated with case no. 3:11-cv-00025-RRB and case no. 3:11-cv-00036-RRB), against Ken Salazar in his official capacity as the US Secretary of the Interior and Rowan W. Gould, in his official capacity as Acting Director of the US Fish and Wildlife Service (the “FWS”). In this litigation, ASRC is challenging the designation of critical habitat for polar bears under the Endangered Species Act, 16 USC §§ 1531-1544 (“ESA”) and is seeking, without limitation, (i) a declaration that the FWS, in designating the critical habitat, violated the Administrative Procedure Act, 5 USC §§ 553, et seq. (“APA”) and the ESA, and (ii) vacatur of the implementation of the critical habitat designation, along with a requirement that the FWS prepare a new habitat designation that complies with the ESA.

ASRC and its co-plaintiffs brought this action (i) under Section 11(g)(1)(C) of the ESA (16 USC § 1540(g)(1)(C)), to address the failure of the FWS to perform mandatory duties under ESA Section 4 (16 USC § 1533(a), (b)) and the ESA’s implementing regulations (50 CFR §§ 424.12-.13, .18-.19) and (ii) under the APA, to address the failure of FWS to comply with the procedural requirements of that statute, non-compliance with ESA legal requirements otherwise not actionable under the ESA and non-compliance with other obligations to Alaska Natives.”
